Arkansas's Freedom Scorecard:
How Our State Legislators Voted on Questions of
Liberty and Good Government

The legislators who served in Arkansas's 88th General Assembly (2011-12) were regularly faced with choices that tested their commitment to education reform, smaller and more ethical government, individual freedom, and lower taxes.

Some legislators failed those tests, while others passed with flying colors.

Introduction

The Advance Arkansas Institute is pleased to present this study of the voting records of those legislators who served in Arkansas's 88th General Assembly (2011-12). This study explains how legislators voted on over 40 notable bills of the session. Notability, of course, is in the eye of the beholder: in this case, the beholder is the Advance Arkansas Institute. Although it is not the role of the Institute to endorse (or condemn) any legislator, we believe that the statistics below illuminate how the voting records of some legislators advanced the values of freedom and good government, while the votes of others stood in the way of writing those values into law.

We ranked the voting records of legislators (in section I) by their fidelity to freedom and good government. We separated those votes into six separate subcategories (in section II), so that anyone who is interested in a more fine-grained examination of particular issues will be able to focus on them. We labeled some legislators (in section III) whose voting records were most consistent with freedom and good government "Friends of Freedom." (Appropriate labels for other legislators are best left as an exercise for the reader.) Notably, this guide does not conclude that any particular vote or voting record is "good" or "bad." You will have to decide whether the Institute's advocacy of free markets, lower taxes, individual responsibility, and limited and transparent government reflects the values

that are important to you. *To emphasize, this document is not an absolute measure of any legislator's merit: it does not constitute an endorsement.* It is intended to be a tool for general research and for accountability, so that the public can assess the work of their elected representatives.

Not all bills that the House voted on made it to the Senate floor; not all bills that the Senate voted on made it to the House floor. **Because of this, scores between the House and the Senate are not meaningfully comparable. That is, you can meaningfully compare the scores of two House members against each other or the scores of two Senate members against each other, but because the different bodies voted on different bills, you can't meaningfully compare the score of a House member to a Senator.** More generally, we have avoided the temptation to assign letter grades, or something similar, to various scores. The numbers that are provided are not absolute measures of quality; rather, they are best used to compare one legislator with another.

All legislators face significant challenges. They are typically required to read, understand, and vote on thousands of bills over the course of a legislative session, while being burdened with other duties in the face of extraordinary time pressures. We may disagree with the choices legislators make, but we respect the burdens of the job they perform.

I - Ranking by Score

The overall (combined and adjusted) scores listed below show how often legislators voted, in our judgment, in favor of free markets, lower taxes, individual responsibility, and limited and transparent government. We then sorted the House and Senate scores so that the legislators whose overall score is most consistent with these values are at the top of each list. For more information on the calculation of these scores, see “Notes on Methodology” below.

II - Voting Records

Most legislators, and their overall score and subscores, are listed alphabetically below. We decided to track votes in six categories: economic freedom, education reform, good government, personal liberty, small government, and tax/budget policy. The leftmost numerical column lists each legislators' overall score; the other numerical columns list subscores as a percentage for each category. The basis for each subscore is described in more detail in the following sections: each legislator was awarded a point whenever he or she voted for a bill that advanced freedom and good government, or declined to vote for a bill that hampered freedom or good government. This method created different

maximum subscores for the House and Senate in some cases.

Legislation is notoriously complex. It is beyond the scope of this paper to supply detailed descriptions of each bill and floor vote that was used to calculate the final score for each legislator. Instead, in addition to the raw voting records, we have supplied a very brief description of the aspect of the bill that was relevant to our judgment with respect to freedom and good government. When there were multiple floor votes, we typically used the one which most cleanly presented a question of freedom and good government. Economic Freedom

Those who appreciate economic freedom will resist (among other things) inefficient or costly regulations, as well as burdens on the right to earn a living. The troublesome bills AAI monitored in this area included HB 1385 (mandates on home construction), HB 1455 (regulations on farmers' markets), HB 1915 (new mandates

on health insurance), and SB 437 (new regulations on pharmacies and their customers). The one bill AAI monitored in this category that sought to expand economic freedom was HB 1893, which established teaching license reciprocity with other states.

Education Reform

Maintaining “a general, suitable, and efficient system of free public schools” is required by the Constitution of Arkansas. Most of the bills that AAI monitored in this category apparently attempted to make education more suitable and efficient, such as SB 303 (removes burdens from students under public school choice law), SB 346 (eases the cap on charter schools), SB 436 (repeals the parent-petition requirement for charter schools), SB 578 (removes

subjective criteria for admission to Governor’s Scholars program), and SB 914 (protects students’ right to public school choice). However, other bills seemed to be aimed at making education less efficient, such as SB 956 (ends the requirement to report public-school grade inflation) and SB 957 (creates additional obstacles to charter-school formation).

Good Government

The role of the legislature is not simply to make rules that govern the conduct of private citizens; perhaps a more important part of the job is to govern the conduct of government itself. Bills aimed at this value included HB 1013 (prevents government from treating law-abiding contractors equally with contractors who knowingly employ illegal aliens), HB 1783 (requires ethics disclosures from election commissioners), HB 1784 (prohibits election commissioners from having business dealings with election boards), HB 1797 (requires

voters to show photo ID at polls), and SB 221 (puts government finances on public website). Other bills embodied an undisciplined or arbitrary attitude toward government power, such as HB 1276 (extends law enforcement authority to private colleges), HB 1808 (exempts state Capitol elevators from safety rules), SB 214 (creates the crime of “cyberbullying” by means of an overbroad and arguably unconstitutional statute), and SB 750 (significantly reduces criminal penalties for multiple crimes).

Personal Liberty

The bills we monitored that protected personal freedom – HB 1917 (the Religious Freedom Restoration Act), HB 1958 (protects concealed carry rights), and SB 115 (blocks local governments from regulating Second Amendment rights) – were outnumbered by the bills we monitored that encroach on personal freedom: HB

Small Government

The bills we monitored in this category all expanded government's reach in one way or another. We monitored HB 1226 in the House but not in the Senate; in the House (but not in the Senate), a vote for HB 1226 was a vote to authorize spending on a PPACA ("Obamacare") state health insurance exchange. The other bills in this category included HB 1898 (creates framework for taxpayers to

subsidize private industries), HB 1936 (establishes statewide school dress-code regulations so as to prohibit the indecency of saggy pants), SB 119 (creates Commission on the Status of Women), SB 345 (creates government database of all Arkansans' drug prescriptions), and SB 65 (encourages increased enrollment in state health insurance programs).

Tax/Budget Policy

The bills we monitored in this category were, with two exceptions, tax reductions that benefited large swaths of Arkansas's population: namely, HB 1002 (reduces taxes on some capital gains), HB 1052 (reduces manufacturers' utility taxes), SB 274 (reduces auto sales tax on some transactions), SB 275 (reduces manufacturers' sales and use taxes), and SB 276 (reduces sales tax on food). It was AAI's judgment

that SB 305 (which created an unemployment trust fund to be funded by tax-increase elections) was an unwieldy and unnecessary way to solve Arkansas's problems in this area, especially given the multiple successes of SB 593 (slightly reduces unemployment benefits; staves off possible tax increase) in addressing the issue.

III - Friends Of Freedom

The top tier of legislators in each chamber, as measured by their overall score, received the Advance Arkansas Institute’s “Friends of Freedom” designation. The evidence suggests that these legislators value personal

freedom, lower taxes, and limited government more highly than some of their colleagues. To repeat, the two chambers’ scores are **not meaningfully comparable** against one another.

Notes On Methodology

Legislators are presented with a number of different options when asked to vote, and these options invite different interpretations. Our own interpretation is that elected legislators are faced with the moral responsibility to express their views on legislation publicly by means of voting on them. In general, we counted a refusal to vote or a “present” vote as a NO vote.

We decided not to give more weight to some votes than to others. It is certainly true that some of the votes described above deal with weightier or more important issues than others. But we decided that if we were going to start giving different weights to different votes, we would be setting ourselves up for some difficulties: we were concerned that we not only wouldn't know where to start, but that we wouldn't know when to stop. In the end, we decided to give the same weight to each vote, on the theory that this is probably the least unsatisfactory alternative. Some readers of this report might object that we should have put additional votes in or left certain votes out. Because the methodology of this report is simple and transparent, those who object to our methods are free to add in or leave out their chosen floor votes and then to calculate their own results.

Our method is confined to the examination of a small fraction of floor votes: most bills that reach the floor are of a technical nature, and do not clearly advance or hamper the values of liberty and good government. We calculated a raw score that was based on a floor vote for or against each

bill that was relevant to the values we measured. For each vote that we thought advanced these values, we added 1 to a legislator's score. For ease of comprehension, we then produced an adjusted (final) score for House members by doubling each legislator's raw score and adding 35 to it. Similarly, we produced an adjusted (final) score for Senate members by tripling each legislator's raw score and adding 30 to it. To repeat, House and Senate scores are not meaningfully comparable across chambers.

This report treats all legislators equally, rather than weighing them according to leadership, committee membership, rank, or bill sponsorship. This reflects the structure of the legislature itself, where the roll call assigns every member exactly one vote. Although leadership and the setting of priorities is a vital part of legislative service, these are highly subjective matters that do not lend themselves to objective measurement. To the extent that one attempts to quantify such subjective matters, one runs the risk of sacrificing the impartiality and the objectivity of a study of voting behavior. Ultimately, voting records provide the best data for objective analysis.

It is traditional that the Speaker of the House rarely casts a roll-call vote on legislation on the House floor. We therefore did not research Speaker Robert Moore's votes or calculate a score for him. Furthermore, because Rep. Fred Smith and Rep. Bruce Cozart did not serve during the entirety of the legislative session, we also eliminated their incomplete voting records from our study.
